### Abstract

*A single paragraph of about 200 words maximum. For research articles, abstracts should give a pertinent overview of the work. We strongly encourage authors to use the following style of structured abstracts, but without headings: (1) Background: Place the question addressed in a broad context and highlight the purpose of the study; (2) Methods: briefly describe the main methods or treatments applied; (3) Results: summarize the article's main findings; (4) Conclusions: indicate the main conclusions or interpretations. The abstract should be an objective representation of the article and it must not contain results that are not presented and substantiated in the main text and should not exaggerate the main conclusions.*

**Key-words:** keyword 1, keyword 2, keyword 3 (List maximum six pertinent keywords specific to the article yet reasonably common within the subject discipline)

### 1.0 Introduction

The introduction should briefly place the study in a broad context and highlight why it is important. It should define the purpose of the work and its significance. The current state of the research field should be carefully reviewed and key publications cited. Please highlight controversial and diverging hypotheses when necessary.

### 2.0 Literature Review

Ensure that all the works mentioned in the reference part are properly cited here. Demonstrate author's familiarity with the topic and scholarly context. Author should position himself/ herself in relation to other researchers, theorists and show how his/ her research addresses a gap or contributes to a debate.

### 3.0 Research Objectives/ Research Questions

Research objectives/ research questions should mention here.

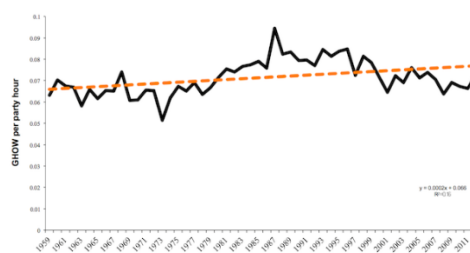
